Pre- Registration will be on a first come first serve basis. Those who register will be given a Unit Permit number, which will be used for line up and for awards. **Permit Placard must be visible at all times.** Units must be at the Saddle Tramp by 8:00 AM on Saturday, February 18th to begin lining up. Those who have pre registered who are late and not on time, might lose their position, due to the lining up of other units that morning.

The Saddle Tramp Riding Club, Inc. is NOT providing any food or drinks to those who have registered a unit. We ask that you remain in your designated order until the run and parade is over. We want you and your participants to enjoy the **Courir** in a safe environment.

The driver of each float / wagon will be subject to a Police Field Sobriety Test throughout the Run.

2012 Children's Courir de Mardi Gras Rules for Floats on the Run

1. All Floats should Pre-register on Friday, 02/10/12 at the STRC Club House. The pre-registration will be on a first come first served basis. Your Float will be assigned a Number identifying its placement in line for the Run and Parade. The Preregistration Cost Per Float is \$ 30.00
2. Float registration on the morning of the Run, Saturday, 2/18/12 will be \$50.00 Cash.
3. A vehicle / truck carrying passengers will be considered a float and will be required to purchase a permit. This includes vehicles carrying queens for the parade.
4. An off road vehicle pulling a trailer/float will be required to purchase a permit.
5. No 4-wheelers / ATV's or Unauthorized golf carts will be allowed during the run.
6. No Horses are allowed on the Run.
7. Floats cannot have to two trailers connected together during the run.
8. No Alcohol is allowed on the run.
9. You must arrange for your own restroom accommodations during the Run.
10. No Food or soft drinks will be provided by the STRC.
